摘要

目 的:

在已颁布的收载了贯众炭中药饮片的地方标准中。中药饮片质量不一。这些不同的略微的差异可能为医疗事故埋下隐患,因此选择此课题来达到为完善贯众炭的全国质量标准和炮制规范提出建议的目的。通过对贯众炭 11 个地区的中药饮片炮制规范的对比分析,为完善贯众炭中药饮片炮制规范提出建议,便于市场监管,利于中药饮片的发展,提高临床应用疗效。

方法:

以中药饮片三级规范标准为研究范围,以贯众炭各地中药饮片炮制规范为研究对象利用文献检索以及比较分析对文献进行比较、归纳、汇总、分析。

结果:

经大量查阅文献,确定目前已经有十一省、市、自治区把贯众炭中药饮片收载入本省、市、自治区中药炮制规范中。但不同地区的贯众炭中药饮片炮制规范 在名称、炮制工艺、炮制方法、功能主治等方面存在略微差异,致使不同地区贯 众炭饮片炮制标准以及质量存在差异。

结 论:

由于地域差异导致贯众炭中药饮片炮制规范不同,不利于饮片的统一管理, 更容易导致医疗事故。所以研究本课题对比不同地区贯众炭的炮制标准,分析各 地区的差异及其原因。然后通过充足的实验研究出在经过炮制工序后有效成分含 量达到最多的统一炮制方法。

Abstract

Purpose:

Therefore, this topic was chosen to make Suggestions for improving the national quality standards and processing specifications of guanjiu charcoal. Based on the comparison and analysis of the processing standards of traditional Chinese medicine decoction pieces in 11 regions of guanzhong charcoal, Suggestions were put forward to improve the processing standards of traditional Chinese medicine decoction pieces of guanzhong charcoal, so as to facilitate market supervision, facilitate the development of traditional Chinese medicine decoction pieces, and improve the clinical efficacy

Material and method:
